महोदय,

ISP had placed purchase order no. 4500017967 dated 09.06.2020 on M/s. Shree Lamipack Pvt. Ltd., Ghaziabad for supply of 75 MT of Polymer Reinforced Paper in reel width of 41 CM, 150 GSM

2. As per terms and conditions of the purchase order, the firm-M/s. Shree Lamipack Pvt. Ltd., Ghaziabad had supplied 05 Reel as a pre-production sample. The material supplied by the firm were tried on machine by user section and found that the printability and runnability of the paper satisfactory. However, failed to meet the various parameters as per tender technical specification. Thus, ISP vide letter no. RENT-P(1106)/2019/1125 dated 26.06.2020 informed the firm that the pre-production sample supplied is found unsuitable and gave one more chance to the firm-M/s. Shree Lamipack Pvt. Ltd., Ghaziabad to supply the pre-production sample strictly as per technical specification of the tender document.

3. Thereafter, the firm- M/s. Shree Lamipack Pvt. Ltd, Ghaziabad has again supplied 05 reels as a pre-production sample on dated 17/08/2020. However, 2nd lot supplied by the firm-M/s. Shree Lamipack Pvt. Ltd., Ghaziabad rejected by the user section due to unsatisfactory performance and not complied with ISP tender specification.

4. Since, the firm-M/s. Shree Lamipack Pvt. Ltd., Ghaziabad had failed to supply the pre-production sample as per tender specification, ISP vide letter no. RENT-P(1106)/2019/4046 dated 17/10/2020 had issued show-cause notice to the firm. However, no satisfactory reply was received from the firm- M/s. Shree Lamipack Pvt. Ltd., Ghaziabad for ISP's Show-Cause notice.

5. Thus, in line with the terms and conditions of tender and SPMCIL Procurement Manual guidelines, I am directed to inform that M/s. Shree Lamipack Pvt. Ltd., Ghaziabad stand banned/blacklisted from participating in any of the tender of India Security Press, Nashik Road and all other units of SPMCIL for the next two (02) years w.e.f 15.05.2021 for passing off inferior quality of materials.

6. The above said purchase order is hereby stands cancelled. Further, Security Deposit/Performance Security submitted in form of Term Deposit Receipt for Rs. 15,28,800.00 is forfeited against purchase order vide PO No. 4500017967 dated 09.06.2020 .
