**महोदय,**

With reference to above, it is to inform that India Security Press, Nashik had placed letter of intent no. BP-PC/225/2020/6257 dated 04/02/2021 on M/s. Sri Venkatesh Paper Agencies, Hyderabad for supply of 45 MT of Buff pulp board sheet. As per terms and conditions of letter of intent the firm-M/s. Sri Venkatesh Paper Agencies Hyderabad had to:-

- Submit the performance security/security deposit amounting to Rs. 4,80,960/- (Four Lakhs Eighty Thousand Nine Hundred and Sixty Only) within 21 days from the date of issue of letter of intent i.e. on or before 24/02/2021.
- Supply 5(five) reams(approx weight of ream is 0.0431 MT) as pilot/pre-production sample on or before 19/02/2021 and bulk supply of 22 MT on or before 06/03/2021, also firm-M/s. Sri Venkatesh Paper Agencies, Hyderabad had to supply the balance quantity i.e. 23 MT on or before 05/04/2021.


2. However, despite of several reminders the firm-M/s. Sri Venkatesh Paper Agencies, Hyderabad had neither submitted the performance security nor supplied the material as per letter of intent/tender terms and conditions. Hence ISP vide letter no. BP-PC/225/2020/7387 dated 23/03/2021 has issued the show cause notice to firm -M/s. Sri Venkatesh Paper Agencies, Hyderabad. In response to ISP's show cause notice the firm-M/s. Sri Venkatesh Paper Agencies, Hyderabad vide email dated 30/03/2021 and email dated 03/04/2021 requested ISP to provide some more time to submit the performance security/security deposit and to supply the material.

3. In view of above, ISP vide letter no. BP-PC/225/2020/208 dated 12/04/2021 has given one more chance to the firm-M/s. Sri Venkatesh Paper Agencies, Hyderabad to submit the performance security/security deposit and supply the pilot/pre-production sample on or before 20.04.2021. But the firm-M/s. Sri Venkatesh Paper Agencies, Hyderabad has neither submitted the performance security/security deposit nor supplied the pilot/pre-production sample.

4. Thus, in line with the terms and conditions of tender and SPMCIL procurement manual guidelines, I am directed to inform that M/s. Sri Venkatesh Paper Agencies, Hyderabad stands banned/blacklisted from participating in any of the tender of India Security Press, Nashik Road and all other units of SPMCIL for the next two (02) years w.e.f 05.07.2021. Further M/s. Sri Venkatesh Paper Agencies, Hyderabad has been removed from the approved list of vendors (i.e. vendor list maintained in ISP SAP system environment) for the period of two (02) years w.e.f 05.07.2021.

5. The above said letter of intent is hereby stands cancelled. Further earnest money deposit submitted by the firm-M/s. Sri Venkatesh Paper Agencies, Hyderabad in form of demand draft for Rs.1,02,800.00/- is forfeited against tender no. 6000014798/59/BP-PC/225/2020 dated 22/07/2020.
