- 1.Delivery period: The Contract period will be for one year from the date of issue of Purchase Order. Since order is on rate contract basis, the prices quoted shall remain fixed except for provision of price variation as per clause no.37 of Section-VII of tendered document. Also Type of vehicle for transportation of goods/material will be based on as & when required basis & invoices will be raised generated as per type of vehicle used.
- 2. Required Terms of Delivery: FOR Currency Note Press, Nashik Road including stacking and unloading properly at site by the firm as shown by our representative.
- 3. Destination: CURRENCY NOTE PRESS, JAIL ROAD, NASHIK ROAD 422 101
- 4. Preferred Mode of Transportation: BY ROAD.
- 5. Bid Validity: 120 days from due date of tender.
- 6. Bidder have to open the link provided in Section II, IV & XII onwards and take print out of all the documents available and then sign and stamp each and every paper and submit along with the technical tender.
- 7. All the copies of tenders shall be complete in all respects with all their attachments/enclosures duly numbered.
- 8. RISK PURCHASE:
- (a) If the supplier after submission of tender and due acceptance of the same, i.e. after placement of contract fails to abide by the terms & conditions of these tender documents, or fails to supply the deliverables as per delivery schedule given or at any time repudiates the contract, the purchaser shall have the right to Invoke the Security-cum-Performance Guarantee if deposited by the supplier and procure stores/take services from other agencies at the risk & consequence of the supplier. The cost difference between the alternative arrangement and supplier tendered value will be recovered from the supplier along with other incidental charges.
- (b) In case of supply/job work through alternative sources at lower price, if any, then no benefit on this account will be passed on to the supplier.
- (c) For all the purpose the award of contract will be considered acceptance of tender and formal contract pending signing of agreement. Supplier has to abide by all the terms and conditions of tender.

# **Section VII: Technical Specification**

### 1. SCOPE OF WORK (JOB SPECIFICATION):

Transportation from JNPT Nhava Sheva port / Mumbai Port/any other yard specified by M/s Balmar Lawrie Co Ltd, either destuffed at port or at CNP. Require trailer, if required low bed trailer to be provided as per requirement.

- a) i) 20'/40' Flat Rack containers or Consignments with content of weight 12 MT to 35 MT. ( 1100 x 300 x 400 in cm)(LxWxH)
  - ii) 20'/40' High Cube Containers or Consignments with content of weight 6 MT to 20 MT (  $1200 \times 300 \times 300$  in cm)(LxWxH)
  - iii) 20'/40' Normal containers or Consignments
- (b) For other imported goods received either by air or ship:
- i) Up to 500 kg
- ii) Above 500 kg to 1 MT
- iii) Above 1 MT to 3 MT
- iv) Above 3 MT to 5 MT
- v) Above 5 MT to 10 MT
- (c) Returning of destuffed/emptied containers back to shipping company/container depot within the admissible time at Mumbai / Nhava Sheva at a location as directed by authorized clearing agent engaged by Currency Note Press.
- 2. To facilitate opening of containers to unload boxes during destuffing, doors of containers should be faced to back side of trailer.
- 3. Transporter will co-ordinate with authorized clearing agent at Mumbai. Transporter is required to co-ordinate with escort team,if deployed. Escort vehicles will be provided by CNP.
- 4. Loading of containers/consignments at Mumbai Airport/JNPT Nhava Sheva are to be arranged by transporter.
- 5. LOCKING: The containers will be locked by clearing agent with consignee's lock provided for this purpose and keys will be handed over to the staff of CISF (if deployed) or accompanying officer of Currency Note Press(if deployed) in a sealed cover to be handed over to the consignee at Currency Note Press, Nashik Road.
- 6. STRICTLY CONFIDENTIAL: The details of goods and other particulars and movement shall be kept confidential by transporter and shall be known only to consignee or their representatives.





- 7. Transporter in co-ordination with clearing agent, CISF (If deployed) and consignee shall arrange movement in such a manner that consignment shall not be required to be detained for unloading/destuffing enroute to CNP. Goods to be transported being high value, proper care should be taken while handling and transportation to avoid tampering of containers, any pilferation, damage etc.
- 8. "CARRIER RISK": The consignment has been insured by CNP under Marine Insurance Policy. Transporter should strictly adhere to full fill the obligation as per insurance norms. Any claim referred by Insurance Company on account of negligence of transporter will solely by borne by the transporter.
- 9. Transporter shall quote for transportation charges per consignment including all other incidental charges, detention charges, other fee's etc.
- 10. The weight mentioned at 1 (a) above is of Machine/spare part and does not include the weight of container. The firm should quote **rate** including container weight.
- 11. Loading of container/consignment in trailers ( or low bed trailers also, if required) at loading site will be done by transport contractor and unloading at Currency Note Press will be done by CNP
- 12. The transporter shall ensure proper closure of doors of the containers at the time of loading/shifting.
- 13. Every Over Dimension Cargo (ODC) consignment must have a proper lashing/choking/bracing. The transporter shall ensure that no container is accepted for road transportation if it has improper lashing/choking/bracing.
- 14. In case of an accident in transit, or for any other reason, if a container needs to be transshipped on to another vehicle/chassis en-route, the transshipment shall be carried-out by the transporter at his cost and risk. The Contractor shall also be liable to pay the compensation/claims arising out of any damage to container and cargo. Including the claims in respect of short deliveries, if any, occurring due to such mishaps. The contractor shall also be liable for any third party claims and damages including the Customs duties/damages for short deliveries, if any, occurring due to such mishaps. CNP reserves the right deduct such amounts from any amount payable to the contractor. The contractor is advised to take appropriate insurance coverage with CNP against such unforeseen events.
- 15. In case of long lead road transportation, events like imposition of restrictions on movement by State Government authorities on a particular route or in certain timings or diversion of routes on temporary basis due to civil works, law and order situation, festivals, etc. shall not form the basis for claiming higher rates.



- 16. The transporter shall not receive and transport any container whose original seals have been tampered with or shoes contents appear to have been damaged and/ or pilfered and will always act only on the instructions of CNP & Balmer Lawrie.
- 17. The contract shall be for a period of one year from date of issuing order.
- 18. ESCORT: If required, CISF/Police officials will be provided by Currency Note Press, Nashik for escort on receipt of information about clearance, if required will be deployed.
- 19. Drivers of the vehicles should have valid license for heavy motor vehicle. He should produce the same, if asked.
- 20. Transporter shall ensure that only transport vehicle in very good running condition are deployed for this purpose and crew with vehicle shall be skilled and of credentials deemed fit for accompanying consignment of high value and security. Also the valid documents required such as RC, PUC, Insurance etc. should be available with the vehicle deployed for the job.
- 21. Transporter shall inform their movement to police stations enroute and also to consignee by informing message of movement. In case of any break down or any difficulties, immediate information shall be conveyed to nearest police station and also to the consignee.
- IOINT SURVEY: Situations may arise during the course of handling/transportation of containers and cargo when a container or cargo meets with an accident. The contractor may avail the services of a Surveyor on his own, at his own cost, if he so desires, to carry out a Joint Survey along with the Surveyor of consignor/Consignee/Insurance Company, etc. for assessment of loss/damage to cargo and/or container. In case the contractor does not provide his own Surveyor for the joint survey, the contractor shall nor raise, subsequently, any dispute regarding the assessed value of loss/damage to cargo and /or container. Moreover, the contractor shall be under obligation to issue " Damage Certificate" to the Consignor/Consignee to claim compensation from the Insurance Company, in the format as desired by CNP. Settlement of claim Consignor/Consignee with Insurance Company should not lead to the conclusion on the part of the contractor that his liability is over. The contractor shall be required to settle all claims/liabilities, whatsoever, against CNP, which come to under all such situations. The contractor may undertake to repair the damaged container, which has met with an accident under his custody, at his own initiative. This shall do to the complete satisfaction of the concerned shipping line/CNP to which the container belongs to at the time of accident.



23. ACTIVITIES TO BE PERFORMEND BY THE CONTRACTOR FOR LOCAL TRANSPORTATION OF CONTAINERS BETWEEN CFS AND PORTS.

The T.O. is required to transport EXIM/Domestic Empty/Loaded containers between CFS/CNP and Gateway ports and its adjoining areas. The T.O will be required to position the trailer at the nominated area at the CFS/Port for loading/unloading of container from/onto the trailers.

The transportation related activities to be covered under this tender are us under:

### 23.1 MOVEMENT OF EMPTY CONTAINERS BETWEEN CNP & VARIOUS CFSs:

This will involve picking up the empty containers from CNP area and transporting the container on trailer to container yards/CFSs located in Ports areas directed by CNP officials, and deliver the same and obtain the receipt of successfully doing so. EIR ( Equipment Interchange Report) for the same on behalf of CNP. The T.O shall arrange to deliver the receipt and other documents to CNP officials.

### 23.2 MOVEMENT OF LOADED CONTAINER BETWEEN CNP VARIOUS CFSs:

This will involve picking up the loaded containers/cargo form the CFSs of port located in port area/ Panvel Area and transporting the container on trailer to CNP. The T.O shall arrange to deliver the receipt and other documents to CNP officials.

### 24. REQUIREMENT:

- 24.1 The contractor must provide adequate number of 20'/40' length trailers for transportation of 20'/40' containers and also low bed trailer so as to receive the total consignment at a time at destination.
- 24.2 The contractor shall provide Low bed vehicles for ODC (Over Dimensional Container) movement, if the dimensions of the container warrants. Such vehicles shall be provided as per the requirement and shall be essentially non-encumbered.
- 25. CONTRACTOR'S OBLIGATIONS WITH REGARD TO ROAD TRANSPORT SERVICES. The contractor engaged to transport containers through road vehicles will observe and abide by all the statutory laws and rules, including safety norms, made by central/State Governments in regard to transportation from time to time. Request for additional payment will be entertained at later stage, if contractor do not abide by late down laws. The transporter has to quote accordingly.
- 25.1 Expeditious Movement of containers: The Transport Contractor shall carry out the various activities assigned to him under this contract expeditiously within the time prescribed by CNP. Transport Contractor should provide adequate/sufficient number of trailers/vehicles for coping up with job order requirement and its timely compliance. Failing which damages shall be applicable as per under mentioned clauses.





- 26. In case of ODC/refer export, the contractor will have to comply the job order using low bed trailers/Genset Vehicles wherever required. As per general trend, the contractor will have to treat these sensitive movements as a special case and should comply with the movement norms followed by the CHA or CNP.
- 27. Before moving the export loaded container, the TRANSPORT CONTRACTOR is expected to acquaint himself with the vessel particulars for the respective container and the vessel gate cut off and also keep his updated regarding any preponment/post-ponment of gate cut off. In case of shut out resulting in return of container form Port gate, the TRANSPORT CONTRACTOR shall not be entitled to get any re-movement charges on return of containers to CNP except in the rare case when the preponment takes place after the container had already been moved out from CNP. In such an instance, the TRANSPORT CONTRACTOR will be paid charges for return movement of containers from Port to CNP. Such instances are expected to be rare and will be dealt with on case basis on submission of documentary evidences acceptable to CNP.
- 28. All the damage if any, will be imposed by the CNP and the same will be deducted from the bill of the contractor. CNP may also deduct the damages from the Security Deposit, incase bills are short of damages amount. In such a case, the contractor shall have to arrange for additional the Security Deposit within a period of three days of the intimation to him.

### 29. SPECIFIC RESPONSIBILITIES FOR ROAD TRANSPORTAITON OF CONTAINERS:

- 29.1 The contractor shall ensure proper closure of doors of the containers at the time of loading/shifting. Failure to do so may be treated as unsatisfactory performance. The container shall be secured to the road vehicle by all four bottom corner fittings.
- 29.2 Every ODC consignment must have a proper lashing/choking/bracing. The contractor shall ensure that no container is accepted for Road Transportation if it has improper lashing/choking/bracing. In case of Open Top Containers, contractor shall ensure that no container is accepted without waterproof tarpaulins to save the cargo from pilferage and adverse weather conditions.
- 29.3 In case of an accident in transit, or for any other reason, if a container needs to be transshipped on to another vehicle/chassis en-route, the transshipment shall be carried out by the contractor at his risk and cost. The contractor shall also be liable to pay the compensation/claims arising out of any damage to container and cargo, including the claims in respect of short deliveries, if any, occurring due to such mishaps. The contractor shall also be liable for any third party claims and damages including the Customs duties/damages for short deliveries, if any, occurring due to such mishaps. CNP reserves the right to deduct such amounts from



any amount payable to the contractor. The contractor is advised to take appropriate insurance coverage against these unforeseen events.

29.4 In the case of long lead Road Transportation, events like imposition of restrictions on movement by State Government authorities on a particular route or in certain timings or diversion of routes on temporary basis due to civil works, law and order, festivals, etc. shall not form the basis for higher rates. The traffic has to be carried by the diverted route or in the permissible timings at the rates quoted in this tender, However for permanent restriction (of more than 15 days) resulting in long haulage, the rates can be revised with mutual discussion.

(Note: CNP shall examine the issue through a Committee of three members, including a member from the Finance, to be appointed by Chief General Manager.

- 29.5 The contractor shall not receive and transport any container whose original seals have been tampered with or whose contents appear to have been damaged and/ or pilfered and will always act only on the instruction of the CHA, i.e. Balmer Lawrie. The contractor shall also be responsible for bringing the containers duly stuffed or loaded outside CFS/Ports with seals intact and hand them over at the appropriate place in the same condition.
- 29.6 In case the contractor fails to promptly substitute vehicles in good working and presentable condition and in case alternative arrangements are made by CNP for Road Transportation of Containers, it will be on the contractor's sole risk and cost, till suitable replacement is provided by the contractor or the cycle of activity as initiated under alternative arrangements gets completed, whichever is later.
- 29.7 The decision of CNP as to the extent of expenditure incurred and/or loss sustained by CNP in this regard shall be final and binding on the contractor. CNP shall have the right to recover such expenditure and loss as sustained by from the security deposit or pending bills of the contractor.

### 30. BRIEF SPECIFICATION OF VEHICLES:

- 30.1 Road trailers/CBT for road transportation of 20'/40' Containers for long distance would be in the form of the truck (including multiaxel) and trailers deployed for the work must be capable of carrying 20' and /or 40' containers. However, as and when required, the contractor should have arrangements to carry 22' and 45' containers at the same rate as that of 20' and 40' container respectively. The vehicles will have to conform to the requirements, specifications/and conditions prescribed in paragraphs below.
- 30.2 Suitable Container securing arrangements should be provided on the vehicles.



- 30.3 Vehicle deployed must be fit for meeting with the stipulation of weight categories as indicated in Motor Vehicles Act and all State and Central Laws. Contractor will indemnify CNP for any fines/penalties imposed by any Authority for his act of violation of any of such laws.
- 31. RATE REVISION CLAUSE/FUEL ESCALATON CLAUSE: The contracted rates shall remain operative throughout the contract period except for variation in High Speed Diesel (HSD) prices which CNP on contractor's request will increase @ 0.3% for every 1% increase or decrease in base HSD (diesel) price and vice a versa due to any government notification etc. duly supported by documentary evidence. The base price will be taken of HSD on date of opening of ender at Mumbai & Nashik as case may be.
- 32. INDEMNITY: Transporter shall give indemnity on stamp paper to General Manager, Security Printing and Minting Corporation of India Ltd., Unit –Currency Note Press, Nashik Road for the cost of containers under his custody for transportation and will remain responsible for container till received back by the owner of the container with clear receipt reports.
- 33. PAYMENT: 100% of payment will be made after successful completion of each transportation job as per schedule of work and without any damage/loss and without any dispute of correct receipt of consignments and on production of bills along with receipt of containers (if containers transported) by shipping company duly endorsed by Balmer Lawrie and Company Ltd, Mumbai, Income tax(TDS) and other statutory taxes, if applicable, will be deducted from the bills.
- 34. No. of containers/consignments to be transported each time and whenever movements shall take place shall be pre decided by transporter in consultation with consignee.
- 35. TERMINATION OF CONTRACT: The Chief General Manager, Currency Note Press reserves the right to terminate the contract at any time and without assigning any reason thereof by giving 7 days notice of their intention to do so in writing to the transporter and transporter shall not be entitled to any compensation by reason of such termination.
- 36. Transporter shall give minimum sixty days notice before terminating the contract so that alternate arrangement can be made by consignee. In case of not giving 60 days advance notice before terminating contract, CNP will go for contracting transportation immediately at the risk and cost of defaulting contractor. Any loss due to termination of contract without sixty days prior notice in advance shall be payable by defaulting contractor to CNP.





### 37. ESCALATION:

Rates quoted are not subject to any variation during contractual period, except for the statutory increase or decrease in the price of High speed diesel. In the event of variation in the price of high speed diesel the transportation rates shall increase/decrease by 0.3% for every 1% variation in the high speed diesel price after the date of submission of the offer.

38. The contractor will abide by all terms and condition of contract. SAFE TRANSPORTATION AND SAFE DELIVERY OF GOODS WITHOUT LOSS/DAMAGE UPTO CURRENCY NOTE PRESS, NASHIK ROAD is the essence of this contract.

### 39. RESPONSIBILITIES WITH REGARD TO LOSS, DAMAGES, SHORT RECEIPT ETC.

The transporter shall take all steps to prevent loss and damage or shortage to goods received by them on behalf of Currency Note Press for transportation. It is incumbent on them to examine carefully all packages received from the clearing agent. They shall promptly obtain survey report/damage report from clearing agent Mumbai in case there is any damage/loss etc. The transporter shall also lodge formal claim for loss or damage to goods on receipt under advice to consignee. The transporter will have to make good to Currency Note Press any loss due to negligence on their part or failure to do so.

### 40. LIABILITIES OF THE TRANSPORTER REGARDING LOSS, DAMAGE ETC.

- (a) The transporter shall abide by all instructions that may be given to them from time to time by the General Manager, Currency Note Press or any office authorized by him on his behalf. They will also be bound to act with diligence and to use skill and to make compensation to the Government for the neglect, want of skill or misconduct of themselves or their servants and agents in carrying out such instructions.
- (b) The transporter shall exclusively be responsible for all the losses or damages due to any cause whatsoever from the time they receive the consignment during the period it is held by them till the time the consignment is delivered to consignee.

### 41. SUBLETTING OF THE CONTRACT:

The transporter shall not sublet, transfer or assign the contract as a whole or part thereof to any other firm.
