2. HIGH RESILIENCE (HR) POLYURETHANE FOAM: The HR polyurethane foam is moulded with density = 45±2 kg/m<sup>3</sup> and hardness load 16 ± 2 kgf as per IS:7888 for 25% compression.

3. ARMRESTS: The one-piece armrests are injection moulded from black Co-polymer Polypropylene.  
4. CENTER TILT SYNCHRO MECHANISM (FOR 9U01RG/9U02RG): The mechanism is designed with the following features: · 360° revolving type. · 3 position locking · Tilt tension adjustment

5. TUBULAR FRAME (FOR 9U12RG): The powder coated ( DFT 40-60 microns ) tubular frame is cantilever type & made of Ø 2.54 ±0.03cm. x 0.2 ±0.016cm.thk. M.S. ER.W. Tube.

6. PNEUMATIC HEIGHT ADJUSTMENT (FOR 9U01RG/9U02RG): The pneumatic height adjustment has an adjustment stroke of 12.0 ±0.3cm.
