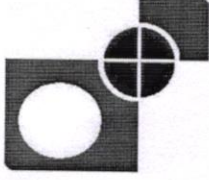

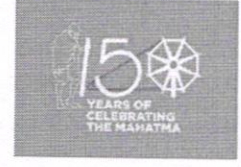

## ANNEXURE-II

### **Parallel Contract Note**

(To be printed on letter head of bidder)

Currency Note Press, Nashik Road reserves the right to conclude parallel Contracts with more than one bidder without any prejudice to the capacity of L1 bidder as given below:

- 1) The Price Offered by L1 bidder will be counter offered to L2 and L3 bidder. On acceptance of counter offer, order will be placed in the ratio of 50:30:20 among L1, L2, L3 bidders respectively. In case of non acceptance of counter offer by L2 and L3 bidder, similar offer shall be given to L4 and so on.
- 2) In case of only one bidder accepts L1 Price then the order will be placed in the ratio of 70:30.
- 3) Incase only L1 bidder is available, the entire quantity will be ordered on L1 bidder subject to availability of his capacity.
