1. Experience & Past Performance:

The bidder should have experience of having successfully completed similar kind of services i.e. A MC(Non Comprehensive) of Operation and Maintenance of 33/11 KV, MRS for the value at least of Rs. 8,26,400/-, in any one of the last five years ending on March-2022.

2. Capability: The bidder must have capability to provide the relevant services i.e. Non Comprehensive AMC Operation and Maintenance of 33/11 KV MRS.

3. Financial Standing:

i) The average annual turnover of the bidder during the last three financial years i.e. 2019-2020, 2020-2021 & 2021-2022 should be more than Rs. 8,26,400/- .

ii) The bidder should not have suffered financial loss for more than one year during the last three financial years i.e. 2019-2020, 2020-2021 & 2021-2022

iii) The net-worth of the bidder should not be negative March-2022 and also should not have eroded by more than 30% in the last three years, ending on March-2022
