1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be

exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

- 2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 4. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
- 5. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. - 6. Procurement under this bid is reserved for purchase from Micro and Small Enterprises whose credentials are validated online through Udyog Aadhaar for that product category. If the bidder wants to avail the reservation benefit, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service.
- 7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 8. 01. Experience and past performance:

The bidder should have manufactured and supplied at least 7000Kgs of Cotton Hosiery Rags in any one of the last five years ending on 31.03.2022

02. Capacity and Capability:

The bidder firm must have an annual capacity to manufacture and supply at least 7000Kgs of Cotton Hosiery Rags

03. Financial Standing:

- (a) Average Annual Turnover of the Bidder firm during last three years i.e. 2019-2020, 2020-2021 & 2021-2022 should be more than Rs. 650,300 /-.
- (b) Bidder firm should not have suffered any financial loss for more than one year during the last three financial years i.e. 2019-2020, 2020-2021 & 2021-2022.
- (c) The net worth of the firm should not be negative in FY 2021-2022 and should not have eroded by more than 30% in the last three financial years i.e. 2019-2020, 2020-2021 & 2021-2022.

Specification of White Cotton Hosiery Rags

SPECIFICATION FOR WHITE COTTON HOSIERY CLOTH/CUTTING

Purpose: This material shall be used for cleaning / removing of various types of inks from printing plates / blankets fr om printing machines.

Technical details:

(a) Size: 30 x 40 cm (minimum)

- (b) The white hosiery cuttings shall be made from good quality of cotton and capable to absorb different varieties of printing inks from plates / blankets.
- (c) White hosiery cloth should not contain any material/coating which is dissolve in solvents like petrol / kerosene et c.
- (d) The supply shall be clean and free from dirt, dust, straws and any other foreign particles like buttons, wire, metal lic buttons, nails etc. to avoid damage to processed plates and rubber blankets while cleaning.
- (e) The white hosiery cuttings shall be free from synthetic cloth and shall have good absorption capacity (i.e. high capacity to soak) of oil, water and other liquid solvents.
- (f) The white hosiery cutting pieces should be soft and smooth in handling and uniform in thickness texture knitting.

Packing: The white hosiery cuttings shall be packed in water proof and dust proof bag of average weight of 50 Kgs. e ach.

Service Line Agreement

(a) The material will be inspected by CNP officials. If any defects observed or any material found unsuitable, then the same should be replaced by the supplier at Currency Note Press, Nashik Road for free of cost. The defective mater

ial(s), if any will be handed over to the supplier at Currency Note Press Stores, against receipt and acceptance of the replacement.

Disclaimer/अस्वीकरण
