1. **Experience and past performance:** The bidder (manufacturer or principal of authorized representative - hereinafter referred simply as 'The Bidder') should have manufactured or supplied atleast 66 Nos. Printing Rubber Blanket in any of the last five years ending on March 2022.

2. **Capacity and Capability:** The Bidder firm must have an annual capacity to manufacture or supply at least 66 nos. of Printing Rubber Blankets.

### 3. Financial standing:

(a) Average Annual Turnover of the Bidder during last three financial years 2019-20, 2020-21 and 2021-22 should be more than Rs. 6,62,000/-

(b) Bidder firm should not have suffered any financial loss for more than one year during the last three financial years 2019-20, 2020-21 and 2021-22.

(c) The net worth of the firm should be positive in the financial year 2021-22 and should not have eroded by more than 30% in the last three financial years 2019-20, 2020-21 and 2021-22

4. The bidders shall give declaration that they have read and understood all the Terms and conditions of the tender document and give unconditional acceptance to all of them.

- A. Special requirement :
  1. The blankets must have uniform thickness all over the blanket surface.
  2. The blankets must have not stretch even at stretching pressure and at high speed of 10,000 sheets per hour (Sheet feed dry offset printing machine.)
  3. The machine direction and grip edge of the blanket should be clearly marked on the back side of each blanket.
  4. There should not any peeling off rubber surface during continuous and prolonged run on high speed machines.
  5. Blankets should be resistant to assorted inks, mineral inks, hybrid inks, metallic inks, quick set inks, etc. and all other chemicals like toluene, petrol, kerosene and other solvents etc. used for washing. There should not be any chemical reaction or swelling etc. due use of chemicals and inks.
  6. The blankets should have dimensional stability, excellent smooth surface, finish all over the surface.
  7. The blanket should have perfect printability on paper with inks used for printing banknotes.
  8. The blanket must have property to limit of pilling of inks and paper dust.
  9. The blanket should be perfect in right angle square cutting within the tolerance of ±0.02mm.
  10. The firm should submit test certificate from Original manufacturer for the parameters mentioned above along with product number and catalogue.
  11. The firm should submit the list Currency Printers to whom they have supplied the materials along with details.
- B. Packing : Set of 15 blankets should be properly wrapped in water resistant and shock resistant air cushioned polythene film and then packed in hard card board cylindrical tube with both ends sealed properly. Box should have sufficient strength to withstand the transportation and handling hazards.

## **Disclaimer/अस्वीकरण**
