If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
2. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. 2. For XPM Compound (chainlink fencing), the firm should use silver color and for Transformers & poles, the firm should use gray color.
3. Firm shall use ASIAN deluxe brand first quality color.
4. Before the start of the work, Firm should approve color shed from CNP representative.
5. The electrical shutdown will be arranged by CNP to facilitate the work.
6. Before start of the work, the firm must remove the grass/shrubs, tree branches if any present, on the fencing compound.
7. The firm shall be solely responsible for safety of their persons working in CNP premises.
8. The painting work shall be carried out with prior permission of CNP representative in Substation.
9. The Firm shall bring their necessary tools and tackles.

3. **Certificates**

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
