2. Two similar completed works each costing not less than the amount equal to Rs. 10,00,000/- or
3. One similar completed work costing not less than the amount equal to Rs. 16,00,000/-.

2. Capacity and Capability Criteria:

The bidder should be enlisted in either Central Public Works Department (CPWD) or Military Engineering Services (MES) or any other Government/PSU/Autonomous bodies.

3. Financial Standing:

(a) Average Annual turnover of the bidder firm during the last three financial years i.e. 2020-2021, 2021-2022 & 2022-23 should be more than Rs. 8,00,000/-.
