The following shall be the minimum eligibility criteria for selection of bidders:

1. Experience and past performance:

The bidder should have experience of having successfully completed similar type of works during last 7 years ending 31.03.2023.

1. Three similar completed works each costing not less than the amount equal to Rs. 39,65,000/- or
2. Two similar completed works each costing not less than the amount equal to Rs. 49,56,000/-or
3. One similar completed work costing not less than the amount equal to Rs. 79,30,000/-.

2. Capacity and Capability Criteria:

The bidder should be enlisted in either Central Public Works Department (CPWD) or Military Engineering Services (MES) or any other Government/PSU/Autonomous bodies.

3. Financial Standing:

(a) Average Annual turnover of the bidder firm during the last three financial years i.e. 2020-2021, 2021-2022 & 2022-23 should be more than Rs. 39,64,600/-.

(b) Bidder firm should not have suffered any financial loss for more than one year during the last three financial years i.e. 2020-2021, 2021-2022 & 2022-23.

(c) The net worth of the firm should not be negative of FY 2022-2023 and should not have eroded by more than 30% in the last three financial years i.e. 2020-2021, 2021-2022 & 2022-23.
