- 1. 02. Capacity and Capability:

The bidder must have capability to provide the relevant services.

03. Financial Standing:

- (a) Average Annual Turnover of the Bidder firm during last three years i.e. 2020-2021, 2021-2022 & 2022-23 should be more than Rs. 5,53,376/-.
- (b) Bidder firm should not have suffered any financial loss for more than one year during the last three financial years i.e. 2020-2021, 2021-2022 & 2022-23.
- (c) The net worth of the firm should not have eroded by more than 30% in the last thr ee financial years i.e. 2020-2021, 2021-2022 & 2022-23.
- 04. The bidder should give a declaration on the letter head of the firm that they have not been blacklisted/debarred for dealing by Government of India in the past.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer

is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
