1. Item: Pet Strapping Rolls - 15 mm. (Virgin material)

2. Colour: Green

3. Thickness: 0.7 mm +/- 0.05 mm

4. Width: 15 mm +/- 1mm

5. Net weight: Approximately 20 Kg. Per roll (excluding the weight of card board Core)

6. Embossing: Should be embossed on both sides of the pet seal for better grip of the pet straps.
