1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of

quality and technical specifications. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

A. Terms and Conditions & Special Instructions:

- 1) The firm/supplier shall consult Currency Note Press, Nashik before carrying out painting work of the vehi cle.
- 2) The firm shall hand over the receipt of vehicle complete with all accessories to CNP.
- 3) The bodybuilding will be inspected at various stages by the authorized officials of Currency Note Press, Nashik.
- 4) The firm shall carry out minor modifications and suggestions if any pointed out by inspecting officer at v arious stages without any additional charges. However, this will not be applicable for major changes since that will amount to deviation from the specifications given above.
- 5) If any of the specification need modifications, the firm may suggest required modifications in their quota tion itself to maintain decent shape of vehicle and to comply with the RTO rules.
- 6) Body builder to be solely responsible for regulatory requirement after the body is built. Construction of b ody should meet the CMVR compliances and truck body code AIS 093.
- 7) At the time of registration of the vehicle if RTO authorities suggest any modifications that will have to be complied with by the firm at their cost.
- 8) The firm has to furnish Indemnity Bond on Rs. 500/- stamp paper duly notarized for the total face value of three TATA truck amounting to Rs. 70,14,537/- only before taking over the truck.
- 9) The truck shall be collected by the successful tenderer from Currency Note Press, Nashik Road. The sole responsibility of the vehicle will be upon the tenderer while the vehicle is being transported to and fro.
- 10) The successful tenderer will be solely responsible for the safe custody and proper maintenance of truc k or any part thereof till the fabrication is completed in all respects and truck is handed over to Currency N ote Press. No part of the chassis will be cut or mutilated by the successful tenderer without prior permission of CNP.

B. MINIMUM ELIGIBILITY CRITERIA

1. Experience and past performance:

- 1.1 For Start-up Firms: The bidder should be enlisted in either Central Public Works Department (CPWD) or Military Engineering Services (MES) or any other Government/ PSU/ Autonomous bodies.
- 1.2 For Other Firm: Bidder should have experience of having successfully completed similar works of ve hicle body building during last 7 years ending March 2023.
- a. Three similar completed works each costing not less than the amount equal to Rs. 5,65,600/-.
- b. Two similar completed works each costing not less than the amount equal to Rs. 7,07,000/-.
- c. One similar completed work costing not less than the amount equal to Rs. 11,31,200/-.
- **2.** The bidder firm has to submit an undertaking / declaration that they unconditionally accept all ter ms and conditions of the tender document including all section without any deviations.
- **3.** The tenderer should have its own machinery, technicians and the list of the same (Company profile) shall be enclosed along with the bid.

Note:-

i. In support of above clause 1 the bidders should strictly produce the copies of purchase orders, e xperience certificates, Job completion certificates of customer as documentary evidence.

ii. Bidders should furnish stipulated documents in support of fulfillment of qualifying criteria. Non submissi on or incomplete submission of documents may lead to rejection of offer.
