- 1. - 1. After completion of installation, commissioning of the instrument , the firm representative shall demonstrate the operation procedure and training given to CNP staff/employees for 3 working days .
- 2. Training will be carried out for 3 working days on testing of different sample of security i nks. (Dry offset ink , Quick set Intaglio ink, Colour shift ink)
- 3. After successful operation of the instrument and testing of different samples of security i nks as per viscosity parameter and CNP specification , if found suitable the suitability will b e given.

2. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

3. Generic
