

4. Bricks: Common burnt clay FPS (non-modular) bricks of class designation. 7.5 shall be used for manhole construction and shall be of size 230 mm x 100 mm x 75 mm. (Tolerance in size: +/- 0.50 inch).



Terms and Conditions

1. Quantity Variation: The above quantities are approximate only. The actual quantities may vary (up to +/-5%) depending upon site requirement while execution of work. Payment will be made as per actual work done quantity only.

2. This contract is of Annual Maintenance nature and therefore, the work shall be executed as & when required. Hence, it may not be necessary that the full quantities of all the items will be exhausted.

3. This contract is for One Year Period.

4. The payment will be made quarterly on the basis of joint measurement for the work executed in that quarter.

5. The firm shall take necessary safety precautions while carrying out the work. Total responsibility of Contractor persons will lie on the contractor & not on C.N.P.

6. The firm shall provide PPE to their workmen while working at site.
