Section VII: Technical Specification

1. Dismantling of existing 3mm thick PVC flooring including removing the layers of Adhesive and cleaning the floor. The scope of work shall also include disposal of the PVC flooring in CNP-IV scrap yard up to a distance of 1.50 Km. The quoted rate shall include cost of all labour, hire charges of vehicle for disposal, tools & tackles etc. complete. (Estimated Qty. 1000.00 m²)

2. Dismantling of concrete floor of grade up to M-20/shahbad stone flooring of thickness up to 4 inches to bring the pot holes in to proper shape for filling epoxy screed. The scope of work shall also include disposal of debris to a designated place up to a distance of 3 Km. The quoted rate shall include cost of all labour, equipment, tools & tackles, hire charges for vehicle for disposal etc. complete. (Estimated Qty. 450.00 m²)

3. Providing and applying self-leveling EPU flooring system with the following scope of work:

(a) Preparing the surface by mechanical scarification, grinding with mechanical grinders, removing of dust particles, oil, grease and cleaning of grinded floor with broom and vacuum cleaner to provide proper key of the EPU coating to the floor.

(b) Filling up gap / cracks if any to the floor where EPU flooring is proposed and level the floor with epoxy mortar wherever required including epoxy primer.

(c) Applying low viscous epoxy primer to a thickness of 100-200 microns with resins and hardner in 1:1 ratio by volume using stiff brush, roller or leveller on dry prepared surface. The primer should be tack free before application of screed coat. Allow the primer to dry to minimum 8 to 12 hours before laying of the screed.

(d) Applying solvent free self-leveling smoothing screed base 4 mm average thickness. The screed coat shall consist of resin, hardner, EPI (Pigment as per final coat) and formulated aggregates Fq. Sand 200. The screed shall be applied by notch trowel and mixing shall be done with an electric variable mixer thoroughly till obtaining homogenous mixture. The spiking shall be followed with spike roller in weight coating to remove entrapped air. The screed coat shall be allowed to cure for 12 Hours.

(e) Laying of self-smoothing floor top coat of 2 mm thickness. The material shall consist of resin, hardner, formulated aggregates and EPI (Pigment/Color shade) in the pre-weighed kit. The color shade shall be approved by CNP. The quoted rate shall include cost of all materials, labour, transportation, equipments, tools & tackles etc. complete. (Approved Make: Cipy/Fosroc Chemicals/Krayon Corporation or Equivalent) (Estimated Qty. 2700.00 m²)

4. Providing and applying wall to floor Epoxy coving of size 70 mm x 70 mm with the following scope of work:

(a) Preparing the surface by mechanical scarification, vacuum cleaning, grinding, removing of dust particles, oil, grease if any to provide proper key to Epoxy coving.

(b) Applying primer coat.

(c) Applying 3" coving by mixing silica sand and epoxy primer.

- (d) Applying epoxy primer on dried coving.
- (e) Applying putty on coving.
- (f) Applying two coats of PU paint.

The color shade shall be approved by CNP. The quoted rate shall include cost of all materials, labour, transportation, equipment, tools & tackles etc. complete. (Estimated Qty. 2500.00 m)

5. Applying aromatic PU coating of approved shade for markings of width 75 mm and 1 mm thickness. The PU coat shall consist of resin and hardner in 1:1 ratio and shall be mixed with sitrrer. The PU coating shall be done with roller. The quoted rate shall include cost of all materials, labour, transportation, sundries, tools & tackles etc. complete. (Estimated Qty. 3500.00 m)

6. Filling of pot holes of depth up to 4 inches with Epoxy screed to make the area in line and level with the adjoining floor surface. The quoted rate shall include cost of all materials, labour, transportation, tools & tackles, equipment etc. complete. (Estimated Qty. 250.00 m²)

7. Raising manhole cover and frame slab for rectangular chambers of size 720 mm x 720 mm for a height up to 250 mm including dismantling existing slab and adjoining floor area and making good the damage. The quoted rate shall include cost of all materials, labour, transportation, tools & tackles etc. complete. (Cost of chamber cover and frame shall be paid separately) (Estimated Qty. 15.00 EA)

8. Providing and fixing Cast iron rectangular cover of size 690 mm x 690 mm light duty without frame for manhole chambers. The quoted rate shall include cost of all materials, labour, transportation, tools & tackles etc. complete. (Estimated Qty. 15.00 EA)

9. Providing and fixing Cast iron rectangular frame of size 720 mm x 720 mm light duty for manhole chambers. The quoted rate shall include cost of all materials, labour, transportation, tools & tackles etc. complete. (Estimated Qty. 15.00 EA)

Terms and Conditions

1. The firm shall arrange for all the materials, consumables, labour, equipment, vehicles, tools & tackles as per the requirement.

5. The firm shall, at no extra cost, cover all the machines and equipment present in the section with tarpaulin and shall also curtain the work area so as to avoid dust to enter in the machine area.
 6. The firm shall take necessary safety precautions while carrying out the work. Total responsibility of Contractor persons will lie on the contractor & not on C.N.P.
 7. The firm shall provide PPE to their workmen while working at site.
 8. Firm shall clean the site before handing over to C.N.P.
 9. The firm shall dispose all the debris generated during the work to the designated place within a distance of 2 Km.
