

- 1) Structural Steel Work: Providing & fixing MS steel pipe 75x25 mm in welding to support the false ceiling/frames of vertical cladding/cat walk/electrical support including cutting, hoisting, fixing position at all heights and locations including painting all such newly fabricated steel work with Synthetic enamel paint (two or more coats) over a coat of zinc chromate yellow primer complete as directed. The quoted rate shall include cost of all materials, labour, scaffolding, equipment, consumables, tools & tackles etc. complete. (Quantity = 2000.00 Kg)
- 2) Aluminium Work: Providing and fixing Anodized aluminium (anodised transparent or dyed to required shade up to 15 microns) work for frame with extruded built up standard tubular sections and other sections of approved make conforming to IS: 733 and IS: 1285, fixing with dash fasteners of required dia and size. Aluminium sections shall be smooth, straight and jointed mechanically wherever required including cleat angle and pan head screws all complete. The quoted rate shall include cost of all materials, labour, scaffolding, equipment, consumables, tools & tackles etc. complete. (Quantity = 375.00 Kg)
- 3) Aluminium Work: Providing and fixing Anodised aluminium (anodised transparent or dyed to required shade up to 15 microns) work for shutters of doors, windows & ventilators including providing and fixing SS hinges and fixing of fittings like multipurpose lock, magnetic catch. Aluminium sections shall be smooth, straight and jointed mechanically wherever required including cleat angle all complete. The quoted rate shall include cost of all materials, labour, scaffolding, equipment, consumables, tools & tackles etc. complete. (Quantity = 150.00 Kg)
- 4) Removing and re-fixing the existing false ceiling sheets in passage of CNP-I as directed from the existing position, after disconnecting false ceiling, lamp, electric supply, taking out the lamps etc. if required /necessary with due care without damaging them, to carry out the trap door work by placing the removed sheets neatly taking due care to avoid any scratches, damages, bends, alignment and level etc. Re-fixing the sheets again at original place and position with necessary self-tapping screw, adhesive if required etc. after completion of trap door framework to form homogeneous appearance without disturbing the line, level of the existing false ceiling erected in passage area of CNP-I etc. all complete as directed including necessary scaffolding etc. (Quantity = 60.00 m2)





- 5) Fixing the existing false ceiling sheet to the aluminum trap door shutter frame arrangement by neatly cutting the existing false ceiling sheet as directed from the false ceiling in passage in required size, pattern etc. and re-fixing the same in true line and level without damaging its profile section to the aluminum framed door shutter with necessary self-tapping screw, adhesive if required etc. to form homogeneous appearance without disturbing the line, level of the existing false ceiling erected in passage area of CNP-I, all complete as directed. (Quantity = 20.00 m2)
- 6) Providing and fixing by mounting 1 mm thick GI sheet over fabricated steel framework at a place at all heights and locations or as directed in a straight line and verticality neatly with the help of necessary self-tapping screws 6 x 50 mm with hex cap and 3mm EPDM seal /riveting and covered with 15 x 3 mm MS flat beading inside and outside as per requirement of site conditions. The item also including painting with two coats of synthetic enamel paint over a coat of zinc chromate yellow primer all complete as directed. The quoted rate shall include cost of all materials, labour, scaffolding, equipment, consumables, tools & tackles etc. complete. - 5. The firm shall weigh the material like structural steel, aluminium section separately (see item no. 1, 2 & 3) in the weigh bridge situated in CNP-IV and obtain duly certified weighment slip from Main Store department.






- 6. The payment for item no. 1, 2 & 3 shall be made by multiplying the length of the section used and actual weight of the section in unit length as per the section collected during the execution of the work.
- 7. The firm shall arrange for all required materials, consumables, equipments, tools & tackles, labour, scaffolding, vehicles etc.
- 8. The firm shall take necessary safety precaution while carrying out the work. Total responsibility of Contractor person will lie on contractor & not on C.N.P.
- 9. The firm is liable to dispose all the debris, building rubbish, MS scrap, and other waste generated during the execution of work pertaining to any items in this contract.
- 10. The firm shall arrange for vehicle for the disposal of the MS scrap, debris, building rubbish and other waste. CNP shall not provide any vehicle for any purpose.
