- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 2. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. - 4. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. However, eligible micro and small enterprises will be allowed to participate .The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023. OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017.
- 5. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted. 6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 7. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 40% of bid quantity, in at least one of the last three Financial years before the bid

opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. 1. Buyer Added Bid Specific ATC

A) Technical Specification

ULTRA FILTRATION MEMBRANE FOR AQUA SAVE PLANT

The membrane/system should be directly replaceable and easily adaptable to the existing Ultra Filtration units.

- 1. Type of filtration should be ultra filtration method.
- 2. The dimension and shape of membranes should be as per the existing Ultra Filtration membranes which c an be provided as sample with active membrane area of 2.2 sq. ft. (0.20 sq.mtrs).
- 3. The flow rate of each membrane 18 to 20 ltrs/hr.
- 4. Maximum operating temperature 60 degree centigrade.

- 5. Maximum feed pressure 6.2 bar (90 psi).
- 6. Molecular weight cut off (MWCO): 150 KDa
- 7. Operating PH range: 2 to 12
- 8. Maximum feed FOG concentration: 50%
- 9. Maximum feed TSS concentration: 80%
- 10. Membrane chemistry and outer shell: Any suitable material with proper sealing in both ends and proper permeate collecting outlet as per sample.
- 11. The firm should provide analysis/laboratory certificate regarding the specification.
- 12. The firm should provide a guarantee certificate along with a shelf life declaration of the product.
- 13. The firm should provide the details like membrane chemistry, required cleaning agents, maintenance sc hedule etc. with supply of membranes.

Delivery and Packaging Details:

- 1. The supply should be packed in sturdy wooden boxes with inner packing to prevent any damage from out side moisture, dust , heat etc.
- 2. The firm will have to provide brochures, manuals available if any in hard or soft copy for handling and sto rage guidelines information about UF membranes.
- 3. The frim should take proper care delivery so as to reach the material in good condition in CNP.
- 4. The bidder will have to supply nos. of Ultrafiltration as per exactly specification for actual plant trial.

Required terms of Delivery:

- (A) Pre-Production Sample:
- a) The successful bidder has to supply 04 Nos. of Ultra Filtration membranes within 30 days of issue of Purch ase Order exactly matching with Technical Specifications.
- b) The Ultra Filtration membranes' extensive trials will be taken and after satisfactory trial CNP will issue the acceptance certificate which shall be communicated by letter/e-mail/Fax.
- c) If not suitable, considering inputs from CNP, the supplier has to supply another 04 Nos. of Ultra Filtration membranes within 15 days of Communication in writing.
- d) Such chances may be given for 3 times.
- e) If suitable, the supplier has to supply remaining Ultra Filtration membranes.
- f) No payment will be made for failed items/material.
- g) The delivery period for the contract shall be 90 days from the date of issue of PO/NAC .
- h) Purchaser reserves the right to alter the delivery schedule as per requirement.
- i) Required Terms of Delivery: FOR Currency Note Press, Nashik Road including stacking and unloading properly at site by the firm as shown by our representative.

- j) Destination: CURRENCY NOTE PRESS, JAIL ROAD, NASHIK ROAD 422 101
- k) Preferred Mode of Transportation: BY ROAD.

B) MINIMUM ELIGIBILITY CRITERIA

The following shall be the minimum eligibility criteria for selection of bidders:

- 1. Capacity & Capability: The bidder must have an annual capacity to manufacturer and supply at least 1 6 Pcs of similar or higher specifications Ultra filtration membranes.
- 2. The Bidder shall give declaration that they have read and understood all the Terms and Conditions (including technical specifications) of the tender document and give unconditional acceptance to all of them.
