- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 4. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
- 5. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023.

- 6. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.
- 7. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 40% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.
- 8. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would be increased to get at least products of one more OEM (directly participated or through its reseller) if available. Further, if bid(s) of any seller(s) eligible for MSE preference is / are coming within price band of 15% of Non MSE L-1 or if bid of any seller(s) eligible for Make in India preference is / are coming within price band of 20% of non MII L-1, then such MSE / Make in India seller shall also be allowed to participate in the RA process.

# 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

#### 2. Buyer Added Bid Specific ATC

#### **A) TECHNICAL SPECIFICAITON:**

-

#### **Scope of Work:**

The firm has to design suitable up gradation with their own control system in line with existing upgraded s ystem of Mitsubishi PLC including supply of the required hardware with latest version PLC system & machi ne program software along with Electrical /Electronics hardware. The proposed up gradation should keep t he existing function of the plant as it is and replace the control system components like PLC and I/O modul es including electrical switch gears used in electrical control panel as required.

The firm has to develop the required software in line with the existing system and should be flexible enoug h to perform modifications to enhance the system as and when required. The existing mechanical system s hould not be altered except to mount the new components. The proposed up gradation should not hamper the present functionality of the plant.

#### **Technical Requirements:**

The system designed should be with Mitsubishi PLC hard ware and should be in line with existing upgraded control panels of Ultrafiltration AB & C. The supplied processor & input/output modules should be as per lat est standards. Minimum group wise isolation (from ground) to be provided with Inputs/outputs. The Inputs/outputs should operate in the environment of 0 to 55 degrees centigrade, RH- 5 to 95% and no condensati on following IEC/EN-61131-2 standard for better trouble free performance.

The existing 5 nos control panels have CS 31 system with decentralized architecture of ABB make and the PLC type 07 KR 91 communicates with the assigned Input / Output ABB modules via CS31 bus, identifying them with addressed node numbers serving as bus master. The PLC has 24 Volts DC power supply voltage and 12 no's of binary out puts in 3 groups (each group consisting of 4 binary outputs) with individual assig ned 110V AC out puts as some of the external components like timers, PID controllers, siren etc. works on 110 V AC. Hence the bidder should take care of it while up gradation. As far as open-ended software should be used. Wherever proprietary versions are used the appropriate license should be submitted to CNP. The software developed for exclusive purpose of CNP, will be transferred to CNP with all owner ship rights.

The software should be made available to CNP Laptop to upload to the hard ware whenever required and complete uploading instructions list should be handed over to CNP.

The proposed PLC and input/output modules should be of Mitsubishi make only, as Aqua save plant has alr eady upgraded 2 panels with the Mitsubishi make PLC and all proposed up gradation control panels are int erconnected.

The Make of electrical switch gears should be ABB/ siemens / Allen Bradley/ Mitsubishi or equivalent

Scope involves following control panels:

- 1) Electrical control panel for Wiping Solution preparation group (Dosage panel)
- 2) Electrical control panel wiping solution correction panel
- 3) Electrical control panel Used Solution Treatment group
- 4) Electrical control panel Filter Press
- 5) Electrical Remote control Panel(central HMI panel)

# Item 01: Up-gradation of Wiping Solution Preparation control panel replacing old panel with n ew one: 1nos

Supply , installation , wiring testing and commissioning of new MS fabricated Control panel painted with acid proof, alkali proof, and rust proof paints ,with IP 55 enclosure class having metal thickness of mini. 2 mm .

The panel shall be designed as per the electrical circuit diagram and required functions of the plant. The p anel shall be inclusive of Switchgear and control gear, PBs, Lamps. Control transformer and SMPS, Aux. re lays Mitsubishi FX5 PLC system with CC link industrial IO network Mitsubishi HMI - 10", colour touch scree n, Level switch controller - 6 no's ,Solid state relay of suitable current rating for 15KW Heater control , - 4 no's as per the functional requirement of the system .

The firm shall supply and install the new panel removing the existing old panel.

# Item 02: Up-gradation of Wiping Solution Correction control panel : 1 nos

Installation , wiring , testing and commissioning of old existing panel with wiring & replacement of Switchg ear and control gear , PBs, Lamps etc. & also providing Control transformer and SMPS, Aux. relays ,CC link remote IO modules ,Level switch controllers -4 no's, Solid state relay for 25KW Heater control - 4 no's etc. as per the electrical circuit diagram &functional requirement of the system.

#### Item 03: Up-gradation of Wiping Solution Treatment control panel: 1 nos

Installation , wiring , testing and commissioning of old existing panel with wiring & replacement of Switchg ear and control gear , PBs, Lamps etc. & also providing Control transformer and SMPS, Aux. relays, providing Mitsubishi FX5 PLC system with CC link industrial IO network. Mitsubishi HMI - 10" , colour , touch scr een Level switch controller - 12 no's ,PH Transmitter device -1 no etc. as per the electrical circuit diagram &functional requirement of the system.

# Item 04: Up-gradation of Filter Press control panel: 1 nos

Installation , wiring , testing & commissioning of old existing panel with wiring & replacement of Switchgea r and control gear , PBs, Lamps ,switches etc. & also providing Control transformer and SMPS, Aux. relays , CC link remote IO modules ,Level switch controller - 2 no's ,Pressure Switch - 7 no's ,Turbidity controller - 1 no's etc. as per the electrical circuit diagram &functional requirement of the system.

#### Item 05: Central HMI control panel :1 nos

Installation, wiring, testing and commissioning of old existing panel with wiring & replacement of old swit chgear & control gear, PB's, switches etc. & also providing new Mitsubishi PLC with CC link and HMI - 10" gty:01no's, as per the electrical circuit diagram & functional requirement of the system.

#### **Software Development:**

The firm shall develop the Software and carry out its integration with the AQUASAVE plant to achieve the o perations and controlling various functions for sole use of CNP. The software developed for exclusive purp ose of CNP, will be transferred to CNP with all owner ship rights.

A suitable means should be made available to CNP to upload the software to the hard ware whenever required and complete uploading instructions list should be handed over to CNP.

#### **B) Final Acceptance Test (FAT):**

Upon completion of entire work, CNP will conduct operational trial on the delivered system in the presence of the firm. The quality and function should match the specifications and requirement of system . The fin al acceptance test (FAT) will be carried out for a period of minimum 8 working days running the entire plant for its production and the results obtained should be to the satisfaction of CNP. If any short fall or bugs in software noticed during FAT, the firm should carry out all the corrective work like modification/alteration / redoing within reasonable period and FAT will be conducted again a fresh.

#### C) Warranty:

The successful bidder has to provide warranty (on OEM Letter head), to the entire upgraded system for fr ee from any defects, for a period of one year from the date of completion of FAT. If any component of the supplied item is rejected due to defect or malfunctioning, during the warranty period the firm should replace the material at their own cost and risk and depute their representative to replacement / to carryout rectification of malfunction if any within reasonable time.

#### D) Training:

The successful bidder should arrange training to CNP engineers for operation and maintenance of the upgr aded system at CNP, free of cost.

# E) Delivery period:

The entire work including design, supply, installation. Integration, programming, commissioning and providing of its performance should be completed within 60 days from the date of placement of order.

However, the firm should plan to take minimum period of time for integration of the up gradation at site .T he firm shall plan the entire execution work at site with consultation of CNP engineer to make availability of plant for up gradation planned accordingly .

#### F) Terms & Conditions:

- 1. The proposed hardware should be supported for spares and services for minimum period of ten years u nconditionally.
- $1.1\,$  The firm shall use all branded new hardware for the up-gradation . The firm shall submit manufacturer authorization for PLC .
- 1.2 The firm shall ensure that all wiring shall be done as per the functional requirement of the Aqua save plant .The modifications , alterations during the up gradation shall not affect the plant performance in any manner.
- 1.3 The Switchgear shall be ABB/ Siemens/ Allen Bradley/ Mitsubishi or equivalent. & PLC & I/O's shall be

Mitsubishi make in line with existing PLC.

- 1.4 The firm shall develop the required software program for the PLC s for the sole use of CNP.
- 1.5 The firm shall provide all technical details of the hardware proposed to be supplied in the plan of up gradation.
- 2. The successful bidder shall provide two sets of operation and maintenance manuals with detailed specifications of different components supplied with the system.
- 3. The firm will have to take all the safety precautions while carrying out the works regarding the safety a nd security of CNP's personal and property.
- 4. The safety of the firm's labours is to be ensured by the firm and CNP disowns any liability in this regard, in case any hazard or accident occurs.
- 5. The firm will have to comply all the CISF, fire and other safety norms of CNP while executing the work.
- 6. The firm will have to carry out the work, from 8.00 am to 4.00 pm including/excluding lunch hours, as the case may be on all working days except Sundays and holidays without hampering the sectional routine works. However, CNP authority will have the discretion to permit work during lunch hour or holidays.
- 7. if any welding work is involved, while carrying out the welding work the firm will have to seek the welding permission from CNP authorities then only work will be initiated.
- 8. The entire responsibility lies with the firm to whom the order has been awarded to restore the old panel and system in case of new system integration is difficult/or unsuccessful for any reason.
- 9. The bidder has to submit all technical details of the hardware proposed to be supplied in the plan of up gradation.
- 10. It is strongly advised to the prospective bidder to visit CNP with prior permission of CNP authorities to u nderstand the specifications and requirements of CNP before quoting the rates else the quotation will be tr eated as invalid.
- 11. The firm shall ensure to restore the old system in case of failure of the upgraded system ensuring all functions and operations of the Aqua save plant.
- 12. Selected contractor needs to provide PVR of Supervisor/ labour's/person's entering in press premises.
- 13. The firm should be capable and possess expertise enough in design, supply, installation of PLC based industrial automation.
- 14. Documentary evidence in support of above eligibility criteria should be submitted along with technical bid. If any firm participating on behalf of their principals/ system house/ system integrator, the firm should submit undertaking from their principals/system house/ system integrator that they are providing all techn ical support and will abide to all CNP terms and conditions and also submit documentary evidence in support from their principals/ system house/system integrator that they are fulfilling both the above eligibility criteria. For technical evaluation the documents submitted by their principals/ system house/ system integrator only are to be considered.

# **H) MINIMUM ELIGIBILITY CRITERIA**

The following shall be the minimum eligibility criteria for selection of bidders:

#### 1. Experience and past performance:

The bidder (manufacturer or principal of authorized representative- hereinafter referred simply as 'The Bid der) should have supplied 03 Nos of Control Panels with latest version PLC System & Machine Program soft

ware with Electrical/Electronic hardware of similar or higher specification in any one year during last 5 year s ending 31.03.2024.

# 2. Capacity and Capability:

The bidder must have an annual capacity to supply at least 03 Nos of Control Panels with latest version PL C System & Machine Program software with Electrical/Electronic hardware.

Note: All experience, past performance and capacity/ capability related data should be certified by the aut horized signatory of the bidder firm.

#### 3. Financial Standing:

- (a) Average Annual turnover of the bidder firm should be more than Rs.16,15,100/- during last three years i.e. 2021-2022 & 2022-2023 and 2023-2024.
- (b) The net worth of the firm should not be negative in FY 2023-2024 and should not have eroded by more than 30% in the last three financial years i.e. 2021-2022 & 2022-2023 and 2023-2024.
- 4. The bidder should give undertaking/declaration that they have read and understood all the terms (with Scope of Work) & conditions of tender documents and submitting unconditional acceptance to all terms & conditions.
- 5. The bidder shall submit offered product catalogue with technical bid.
- $6. \ The firm \ should \ attach \ valid \ authorization \ certificate \ obtained \ from \ manufacturer \ of \ PLC \ \& \ Switchgear.$

#### 7. Note:-

- (i) In support of experience criteria, the bidder has to submit attested copies of P.O's, Experience certificat es issued by customers.
- (ii) All experience, past performance & capacity/ capability related/data should be certified by the authoriz ed signatory of the bidder firm. The credentials regarding experience and past performance to the extent r equired as per eligibility criteria submitted by bidder may be verified from the parties for whom work has b een done.
