- 1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. - OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017.
- 2. Procurement under this bid is reserved for purchase from Micro and Small Enterprises having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal. If the bidder wants to avail themselves of the reservation benefit, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible to participate in this bid. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility based on documentary evidence submitted, while evaluating the bid. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.
- 3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 4. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to

next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would be increased to get at least products of one more OEM (directly participated or through its reseller) if available. Further, if bid(s) of any seller(s) eligible for MSE preference is / are coming within price band of 15% of Non MSE L-1 or if bid of any seller(s) eligible for Make in India preference is / are coming within price band of 20% of non MII L-1, then such MSE / Make in India seller shall also be allowed to participate in the RA process.

# TECHNICAL SPECIFICATION

## Item No. 1 BFM/Shrinkwrap film/ 350mmpoly

i. Material: LDPE

ii. Shape: Center fold

iii. Roll Width: 350 mm ± 2 mm

iv. Thickness: 50-52 Microns

v. Colour: Transparent

vi. Weight of each roll: In the range of approx.15 to 18 kg

vii. Shrink wrap Temp.: 160°C to 180 °C

viii. Cutting & Sealing temp: 180 °C to 200 °C

ix. Outside Roll diameter: 260-300 mm

x. Plastic core (ID): 75 mm ± 1 mm

xi. Winding: Winded on joint free single plastic core, compact & tight.

xii. Perforation: 65 to 75 perforations per 100 Sq. cm ( $10 \text{ cm} \times 10 \text{ cm}$ ) or perforation at every 15mm distance in matrix form. Roll should be micro perforated with the hole diameter of 0.5 to 0.6 mm throughout length.

#### **Terms & Conditions:**

- **1. Packing:** Each roll should be packed properly to prevent any damage to its edges during transit, loadin g and unloading. It should be packed in proper packaging with water-proof material.
- **2. Misc.:** Even after giving the initial suitability of bulk supply of material, if the shrink wrap roll found def ective / damaged during actual usage on machines, the defective material will have to be replaced by the supplier at their own cost & risk as and when intimated to the supplier till the supplied stock consumed.
- **3. Delivery**: After Contract, the firm should supply 150 kg of material initially for actual trial on machine b efore effecting bulk supply.

## **Delivery schedule:**

- 1. 1st supply 24850 kg within 30 days from P.O. date.
- 2. 2nd supply 25000 kg within 30 days from 1st supply.
- 3. 3rd supply 25000 kg within 45 days from 2nd supply.

## **B) MINIMUM ELIGIBILITY CRITERIA**

### The following shall be the minimum eligibility criteria for selection of bidders:

### 1. Capacity and Capability:

The bidder must have an annual capacity to manufacture and supply at least 30,000 Kg of Shrink Wrap fil m.

The bidder has to submit the following details along with the bid:

- i. Name of the machine utilized to supply the quoted product.
- ii. The number of machines being utilized for the production and the capacity of each machine.
- iii. Total Annual Capacity of Manufacturer.
- iv. Supply orders in hand and proportionate capacity to supply quoted amount.

#### 2. Financial Standing:

The net worth of the firm should not be negative in FY 2023-2024 and should not have eroded by more than 30% in the last three financial years i.e. 2021-2022, 2022-2023 and 2023-2024.

- 3. The bidder should give undertaking/declaration that they have read and understood all the terms (with technical specification) & conditions of tender documents and submitting unconditional acceptance to all t erms & conditions.
