- 1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023.
- OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017.
- 2. Procurement under this bid is reserved for purchase from Micro and Small Enterprises having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal. If the bidder wants to avail themselves of the reservation benefit, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible to participate in this bid. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility based on documentary evidence submitted, while evaluating the bid. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.
- 3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 4. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would be increased to get at least products of one more OEM (directly participated or through its reseller) if available. Further, if bid(s) of any seller(s) eligible for MSE preference is / are coming within price band of 15% of Non MSE L-1 or if bid of any seller(s) eligible for Make in India preference is / are coming within price band of 20% of non MII L-1, then such MSE / Make in India seller shall also be allowed to participate in the RA process.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Buyer Added Bid Specific ATC

MINIMUM ELIGIBILITY CRITERIA

The following shall be the minimum eligibility criteria for selection of bidders for Plywood Shooks and Woo den Battens:

01. Capacity and Capability:

The bidder should have an annual capacity to manufacture and supply at least following quantity of the tendered material:

For Schedule 1 (Plywood Shooks): 2000 SETS

For Schedule 2 (Wooden Battens): 1200 CFT

02. Financial Standing:

The net worth of the firm should not be negative of F.Y. 2023-24 and should not have eroded by more than 30% in the last three financial years i.e. 2021-2022, 2022-23 & 2023-24.

- 03. The bidder should give a declaration on the letter head of the firm that they have not been black-listed/ debarred for dealing by Government of India in the past.
- 04. The bidder should submit Power of Attorney of the Authorized Signatory for signing the bid, entering in to contract, if awarded and for any other correspondences.
- 05. The bidders shall enclose copy of GST Registration Certificate (in REG 06 format) & copy of PAN Card.
- 06. The bidder should give undertaking/declaration on the letter head of firm that they have read and und erstood all the terms & conditions of tender documents and submitting unconditional acceptance to all terms & conditions.
- 07. The bidder has to provide the undertaking that "We have read and accept all the terms and conditions of GIT & GCC of the tender document".

Other Notes:

- 1) In support of capability criteria, the bidder has to submit attested copies of PO's, Experience Certificates issued by customers.
- 2) All capacity/capability related data should be certified by the authorized signatory of the bidder firm.
- 3) Purchaser reserves the right to alter the delivery schedule as per requirement.
- 4) Anti-Bribery Management System (ABMS): By participating in this tender, the suppliers/Vendors/Contra ctors are deemed to have undertaken that they shall not give or take, any financial or non-financial bribe, to or from anyone during the tender or during the execution of the contract thereafter and if they notice an y such incident happening, they shall report it to Vigilance.

Terms and Conditions

- 1) For Currency Note Press, Nashik Road including stacking and unloading properly at site as shown by our representative.
- 2) In the supply of plywood shooks, some shooks shall contain ISI mark to represent that the whole sets of plywood shooks are made out of ISI mark plywood.
- 3) 100% Quantity shall be supplied in a single lot.
- 4) Firm should enclose signed copy of specification in token of acceptance, along with the quotation.
- 5) Firm should furnish the self-certificate that the plywood shook's supplied are made of ISI plywood and a nti-termite treatment is given.
- 6) Entire supplies of shook's shall be supplied firmly bundled together. Each bundle should contain 5 (Five) top &5 (Five) bottom,10 (ten) sides and 10 (ten) ends.
- 7) Each bundle shall be marked with Item code (Type F)
- 8) The warranty period applicable for the material shall be 03 months from the date of suitability and acceptance.

4. Certificates

5. Generic

6. Warranty

Warranty period of the supplied products shall be as given in specifications from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after

7. Generic
