- 1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. - OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017.
- 2. Procurement under this bid is reserved for purchase from Micro and Small Enterprises having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal. If the bidder wants to avail themselves of the reservation benefit, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible to participate in this bid. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility based on documentary evidence submitted, while evaluating the bid. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.
- 3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

4. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would be increased to get at least products of one more OEM (directly participated or through its reseller) if available. Further, if bid(s) of any seller(s) eligible for MSE preference is / are coming within price band of 15% of Non MSE L-1 or if bid of any seller(s) eligible for Make in India preference is / are coming within price band of 20% of non MII L-1, then such MSE / Make in India seller shall also be allowed to participate in the RA process.

1. Buyer Added Bid Specific ATC

Technical Specification

i. Internal size of Box = 690 mm (L) \times 620 mm (W) \times 310 mm (H).

- ii. The packing cases of size as mentioned above shall be made out of block board conforming to IS 1659:1 990 revised to 1659:2004 (RA-2004) (interior grade) of uniform thickness 19 mm.
- iii. Box shall be made of 6 pieces and none of the six block board pieces used for the assembly of the boxe s should have any joints on the surface as the boxes will be used for packing the Security Documents.
- iv. Boxes should be supplied as per the drawing enclosed in tender.
- v. Five layered block board of well-seasoned good quality wood shall be used consisting of top & bottom face veneers of 0.5 to 0.6 mm thick and top & bottom core veneers of 1.8 to 2.0 mm thick.
- vi. The center core battens of the block board should be softwood or medium density wood with minimum (14 mm \pm 0.5 mm) thickness, width of 30 mm \pm 1 mm and 300 mm length joined together in staggered fo rmation.
- vii. All layers should be well seasoned & well bonded with BWR/MR grade adhesive conforming to IS 848:1 974. There should not be any gap between the battens used in the block board.
- viii. Nails of size 65 mm x 12 SWG with washers should be used for assembling the boxes.
- ix. The ends of top & bottom sides of the boards should remain slightly elevated as shown in the assemble d view of the drawing, so that the top & bottom lids can be flushed in side to make the level remain unifor m all the sides.
- x. Boxes should be of sufficient mechanical strength & shall be able to carry and withstand product weight of 125 Kilogram under jerks & rough handling during loading and unloading in Treasury van. These will be stacked five boxes high one over the other in the treasury.
- xi. The nailed & strapped box should not get opened or de-shaped while dropping from a height 7 feet with load of 125 Kilogram. The supplied boxes would be checked randomly and in case of any defects, variation in specification it will be rejected.
- xii. Required terms of Delivery: (A) Pre-Production Sample:
- a) Each of the successful bidder has to supply 10 Nos. of Block Board Boxes within 15 days of issue of Purc hase Order exactly matching with Technical Specifications.
- b) The Block Board Boxes extensive trials will be taken and after satisfactory trial CNP will issue the accept ance certificate which shall be communicated by letter/e-mail/Fax.
- c) If not suitable, considering inputs from CNP, the supplier has to supply another 10 Nos. of Block Board B oxes within 15 days of Communication in writing.
- d) Such chances may be given for 3 times.
- e) If suitable, the supplier/s has to supply boxes in equal monthly instalment within six month. (This quantity will be split as per parallel contracts) of receipt of communication in writing.
- f) No payment will be made for failed items/material.
- g) The delivery period for the contract shall be 180 days from the date of issue of PO/NAC.
- h) Purchaser reserves the right to alter the delivery schedule as per requirement.
- i) Required Terms of Delivery: FOR Currency Note Press, Nashik Road including stacking and unloading pr operly at site by the firm as shown by our representative.
- j) Destination: CURRENCY NOTE PRESS, JAIL ROAD, NASHIK ROAD # 422 101
- k) Preferred Mode of Transportation: BY ROAD.

Technical terms and condition for suitability:

- 1. The past suppliers of block board boxes to Currency Note Press, Nashik Road will not be allowed to participate in the development tender.
- 2. Three chances will be given to successful vendors.

- 3. The supplier must enclose a certificate from a Govt. approved laboratory that the block board used for making the boxes is confirming to IS 1659:1990 revised to 1659:2004 (RA2004) interior grade.
- 4. The boxes should be neat, clean and uniform in dimension & as per specification.
- 5. The colour of the boxes should not be dark and the stenciling on the box at CNP should be readable.
- 6. The Anti-Termite and Warranty certificate should be provided for each lot supplied.
- 7. The boxes should be without any defect and variation in specification.
- 8. The interested firm may visit CNP to see the sample before submission of offer.

MINIMUM ELIGIBILITY CRITERIA

1. Capacity and Capability Criteria:

The bidder must have an annual capacity to manufacture and supply at least 5600 Nos. of Similar kind of Wooden Boxes or Block Board Boxes.

2. Financial Standing:

The net worth of the firm should not be negative of FY 2023-2024 and should not have eroded by more than 30% in the last three financial years i.e. 2021-2022, 2022-2023 & 2023-24.

- 3. The bidder should give undertaking/declaration that they have read and understood all the terms & conditions (with technical specification and Diagram) of tender documents and submitting unconditional acceptance to all terms & conditions.
- 4. The bidder has to provide the undertaking that "We have read and accept all the terms and conditions of GIT & GCC of the tender document". Link to GIT & GCC are as follows:

4. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

5. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 % of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity ÷ Original quantity) × Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

6. Generic

Supplier shall ensure that the Invoice is raised in the name of Consignee with GSTIN of Consignee only.

7. Generic

While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the screenshot of GST portal confirming payment of GST.

8. Warranty

Warranty period of the supplied products shall be 1 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
