1. In case of abnormal/ repeated failure of items while in service, bidder shall depute their service engineer free of cost to analyze the root cause & to rectify the same. Bidder shall confirm same in the technical bid.
2. The items supplied shall be of latest/ best design manufactured all over the world.

(II) Qualification/Eligibility Criteria:

(a) For MSE/Start-up firm: Capability- Equipment & Manufacturing Facilities: The bidder firm should have capability to manufacture and supply of tendered item.

(b) For other firm- Experience and past performance: The bidder firm may be Manufacturer/ Proven supplier/authorized dealer or distributor of tendered item or bidder may participate with manufacturing authorized form (issued by manufacturer of tendered item).
